VIVALDI Team	Have been asked by NIHR to evaluate the training that is taking place so that they can consider providing funding. Funding will be provided for a person to come in and help formally evaluate, consequently, write up as a research study and explain how this training programme is working, which will, in turn, give us something to share with the funder towards the end of the project and provide a starting point for the next version of the training.

Louella	Feedback was given from the Care Home visit to Summerlands Care Home in January 2024. Residents were excited. A family member (Sue) started to advocate. No residents have opted out. No questions have been asked that could not be answered by referring to the website or the information provided.	
VIVALDI Team	Holding the first 30-minute drop-in session for onboarded providers on Wednesday, 3rd April 2024, and then monthly from then on.	03Apr24 and ongoing
VIVALDI Team	The most frequently asked question is 'When will we be starting?' We will develop and send out a timescale update to keep everyone informed.	April

Kate Collins	Feedback from Bracebridge Care – similar to Summerlands. Positive comments from residents and relatives. Main question again is ‘When will we be starting.’ All excited to get going! Sharing the information on the website and this has proved to be useful and easy to navigate. No residents have wanted to opt out and there have been no difficult or unanswerable questions so far.	
Helen Hill	Feedback from Great Hawksley Manor (Stow Healthcare) – Carried out a relative’s meeting to talk about the project and everyone was really excited about the big picture stuff and public health implications moving forwards. Questions asked were ‘Why has it taken so long to get to this point – this is how we start to conduct meaningful research!’ Very positive.	
Rights for Residents	The animation was shared on the Care Rights UK and Rights for Residents groups with very positive feedback. Would love to pick up some themes that are coming through from Rights for Residents to feedback into the SOGG group too.	Ongoing
Laura	Laura would like to have a research slot to discuss ideas for potential future projects and use this network, if everyone felt it was acceptable, and link data that we are setting up to deliver research studies – Research studies can mean surveys, questionnaires, interviews through to clinical trials – for example around vaccines. Funded partly by the drug company or entirely funded by the public sector. If anyone has any thoughts about this, please do let us know.	Open for discussion
