





Terms of Reference - Engagement Workstream

Future Forward Vivaldi Care Home Study – Improving Outcomes through Research

1. Context

Care England, University College London, and the Outstanding Society have recently started working together to tackle the problem of infection in care homes, by establishing 'The Future Forward Vivaldi Care Home Study'. The study will be co-developed by care providers, relatives, residents, staff and researchers, with the goal of creating a programme of research and surveillance in care homes to reduce the impact of infection. The programme will have the needs and priorities of people living and working in care home at its core and will build on lessons learned during the pandemic and the Vivaldi study, which was set up to measure COVID-19 infections in care home staff.

2. Purpose

The aim of this working group is to agree an approach to engagement and communication for the pilot study that is acceptable to care home residents, staff, relatives, stakeholders and providers

We aim to Increase involvement of people who use the services and stakeholders in the management and development of the engagement and communication channels by identifying best practice and creating innovative resources.
