Local Priorities:

Claire Stone – a priority that isn't nurse specific, but in terms of the clinical and care professional leadership bit, how can we include health and social care clinicians in some of the improvement stuff that we do and the kind of system approach.

Claire Pegg - how NIHR can support your social care nurses for those that work in social care, access some of the opportunities they've got for further development and how we can really encourage our nurses to start looking at how they can directly influence the care of their patients through research.

Theresa Corkill – to raise the profile of social care, really share the amazing research, the work and the care that is given. At the University of Brighton we are keen for all of our students to experience placement in social care settings.

Pat Conteh – to be able to raise the profile of health and social care, start to understand some of the challenges by sharing experiences that we have in complex care in the community and start looking for solutions around things like training and funding. Upskilling within social care would take pressure off the NHS. Much as Skills for Care are doing a lot of work around delegated healthcare, there needs to be a better understanding around delegated healthcare. Increase understanding of what social care is and does. Social Care needs structure (like NHS has bands in nursing)

Kate Meacock – sharing best practice, breaking down barriers in communication between families, social care and those involved in social care. From an outside perspective – Clear messaging! What is a Social Care Nurse? What do they do?

Helen Evans – raising the profile of social care nursing within student programmes. Thinking about placement issues that need to be addressed – and from a student perspective how we can look at, raise and change issues within social care nursing.

Debbie Clark - making sure that when we're talking about social care, we remember the young people because we are working with young adults. Access to training.

Marissa Spice - raising the profile of social care. Student placements. Exposure to anybody, not just nursing students, but paramedics and anyone that is willing to come through the door and learn what Social Care is about. Delegated healthcare tasks. Work to change the perception of what Social Care is (maybe a visually map on the website).

Wendy Newnham - the broader development of integrated neighborhood teams and how we make sure that social care nurses are key as a foundation within those integrated neighborhood teams. And linked to that is the continuity of care and safety for patients.

Heidi Beddall - delegated healthcare tasks. The opportunity for us to consider how we attract more nurses to social care and raising the profile - how do we engage them in social care during their training and education, and how do we develop really progressive career pathways to give people opportunity to make a career out of social care nursing.



Melanie Bessant - connectivity across the ICB and across the region, interested to understand what everybody else is doing and how we can learn from each other.

David Porter - the challenge we have from a regulatory perspective is how do we reach out to those working in social care and how do we make sure that they're aware of developments, make sure that they're getting the support that they want. If they are supported, they're managed appropriately, then the level of care that those individuals will provide will increase. How we can reach out to these nurses and nursing associates working in social care so that we can, within our resource constraints, provide the support that we would like to?

Joanna Grant – support for senior nurses working in social care. Access to training and supervision and increased research in social care nursing. Also agree delegated health care tasks. Need to look at the tasks that are and aren't delegated, particularly in complex care. RCN are looking at things like suctioning/deep suctioning, those sort of things and what belongs to health and what belongs to social care and what's a nursing task, what's a carer task. We can look at it from the South East, but it is actually a national issue. Look at transition from child to adult services.
