Local Priorities:

Anthony Birmingham: Sharing good stories that show best practise and how things have been approached.

Rory McDonnell: Partnering with universities to help shape the image of what it means to work in Social Care. Improve the lack of understanding of what community needs and what community nursing involves

Nicola Greenwood: Reframing the narrative that comes out of our HEIS and trying to create that parity of a nurse's nurse. It is the nurse's choice to choose the direction of their career rather than being subliminally pushed towards and career in the NHS. Reinforcing the really valuable contribution that nurses in Social Care make and can make and that it is a really worthwhile career choice. Showcasing the fantastic work that Social Care Nurses do. Training for clinical skills.

Karen Morse: Dispel some myths. Can we do something positive on exit interviews to encourage people not to leave nursing altogether and to have a change of direction, train and use their management skills to support people. Prevention – we need nurses and communities and peoples homes far more than they are now!

Jo Cameron: Workforce wellbeing. Connections – what is on offer from ICBs and local authorities? Delegated healthcare activity. Safeguard, innovate and grow.

Michelle Raddings: Celebrate and promote what's available in Social Care. Advocating for making thisgs better and for highlighting challenges and what we can do to try and work better as an integrated system. Show casing those not showcasing!

Leanne Hume: Identification of priorities – both national and regional. Changing some of the narratives for these stories. Recruitment and retention. Workforce wellbeing. Raising the profile of Social Care regionally with our universities to see what we can do to support. Supporting employers to take students. Nurse Associates and the role they play within the nursing team.

Loucia Kyprianou: Making sure there is a consistency of messaging.
