## Meeting Summary:

**Meeting Introductions:** Nuno welcomed everyone to the 3rd London Regional Social Care Nursing Advisory Council meeting, highlighting the importance of collaboration between Social Care and the NHS. New members Karen Bonner, Diane Jones, Darren Jones, and Tom Pisani (attending on behalf of Lauren Hague from Care England) introduced themselves.

**Population Health Management System Data:** Nuno discussed the need for a population health management system dashboard from different ICBs to understand the population needs in terms of older population with Social Care needs. Diane Jones and Karen Bonner agreed to have an offline conversation to take this forward.

**Virtual Wards:** Louise Keane provided an update on virtual wards, highlighting the lack of understanding of Adult Social Care among virtual ward staff. She emphasised the need for training and collaboration to ensure proper delegation of tasks and support for care home staff.

**IV Treatments in Care Homes:** Louise Keane suggested working with Capital Nurse to roll out IV treatments in care homes, including developing a policy and training for Adult Social Care staff. Richard and Peter agreed to work on understanding the insurance implications.

**Student Placements in Adult Social Care:** Nuno shared data from Middlesex University showing that only 10% of Nursing students had a placement in Adult Social Care. The group discussed the need to increase this percentage and ensure every Nursing student has an Adult Social Care placement during their studies.

**Nursing Competencies in Social Care:** Nuno presented a draft list of over 70 competencies required for nurses working in care homes. The group discussed the need for standardised guidance to ensure high-quality nursing care in social care settings.

**London Ambulance Service Incidents:** Nuno mentioned that the lead GP for care homes in the London Ambulance Service would provide data on incidents involving care homes at the next meeting, allowing for a discussion on potential solutions.
