## **Summary Notes:**

- **Council Membership Review:** Zoe and Scarlett discussed the importance of having representation from all six ICBs within the South East region. They emphasised the need for frontline nurses from various sectors to join the council and contribute their insights.
- Clinical Competencies Task and Finish Group: Scarlett provided an update on the clinical competencies task and finish group, highlighting their collaboration with London and QNI. They are currently collecting feedback on the broad framework of skills required for social care nurses.
- **Communications Task and Finish Group:** Zoe discussed the progress of the communications task and finish group, which aims to create a central resource for adult social care nurses to access information about grants, research opportunities, and updates from national organisations.
- **Events Planning:** Zoe and Scarlett proposed organising events for International Nurses Day and Brighton Pride to celebrate and promote collaboration between health and social care sectors. They invited participants to share their ideas and join the events workstream.
- **Data Collection and Analysis:** Andrea and Scarlett discussed the importance of collecting and analysing data on hospital admissions and safeguarding trends. They plan to identify the top three priorities for the region and work together to address them.
- **Insurance and Liability Issues:** Marisa raised concerns about insurance coverage for advanced nursing care in social care settings. Deborah Sturdy and Scarlett shared their experiences and suggested potential solutions to overcome these barriers.
- **Rotational Nursing Posts:** Sharon discussed the potential benefits of rotational nursing posts between social care and other sectors. Deborah Sturdy and Andrea supported the idea and emphasised the importance of breaking down barriers to facilitate such initiatives.
- **Future Leadership Development:** Deborah Sturdy emphasised the need to nurture and develop future nursing leaders. She encouraged current leaders to bring aspiring nurses into leadership roles and provide them with opportunities for growth.
- **Meeting Conclusion:** Zoe summarised the key action points and next steps, including setting up a splinter group for event planning, finalising council membership, and collecting data on hospital admissions. She thanked everyone for their participation.
