Summary Notes:

Social Care Review: Deborah Sturdy provided an update on the social care review being led by Baroness Casey, focusing on delegation and clinical safety. She mentioned ongoing work and upcoming meetings to discuss the future of social care nursing.

Research and Cred Talks: Deborah Sturdy discussed the success of the cred talks and the importance of research in social care nursing. She mentioned upcoming meetings with key stakeholders to expand research opportunities and support clinical academic posts.

National Nursing Board Proposal: Deborah Sturdy and Duncan Burton are working on a proposal to establish a national Nursing Board to ensure a system-wide approach to nursing, including education, research, and collaboration with nursing charities.

Public Health and Digitalisation: Deborah Sturdy highlighted the importance of public health and digitalisation in social care nursing, mentioning ongoing meetings and the need for good data sets to demonstrate care impact and support commissioning.

RCN Support for Social Care Nurses: Deborah Sturdy shared that the RCN is committed to supporting social care nurses, with plans for an event in May and discussions about free CPD opportunities for social care nurses.

Delegated Healthcare Activities Working Group: Karen Roberts provided an update on the delegated healthcare activities working group, discussing the importance of standardising training resources, addressing system barriers, and sharing success stories.

Increasing Social Care Placements: Natalie Dyrlaga discussed her role in increasing social care placements for nursing and allied health professional students, working with providers and universities to expand placement opportunities in non-traditional settings.

Regional Communication Plan: The group discussed the importance of regional communication and sharing information through existing networks, newsletters, and events to raise awareness about the work of the SCNACs.

National Priorities and Regional Support: The group agreed to focus on national priorities such as workforce planning, education, and training, and to identify regional projects and challenges that the SCNACs can support.
