Summary Notes

Council Meeting Introduction: Emily welcomed everyone to the third Regional Council meeting and apologised for rescheduling due to her illness. She confirmed that the meeting agenda and action points were sent out prior to the meeting.



Chief Nurse Update: Deborah Sturdy provided an update on the recruitment of a new Co-chair to support Emily. She also discussed the appointment of Baroness Casey to review social care reporting, the digitalisation agenda, and the importance of delegation in nursing.

Nursing Research Agenda: Deborah Sturdy highlighted the expansion of the nursing research agenda, including the CRED talk programme and the work of Claire Pryor and Allison Richardson on demand signalling for social care nursing priorities.

Upcoming Conferences and Events: Deborah Sturdy mentioned upcoming conferences, including the RCN conference in May and an event with Baroness Watkins in the autumn. She also discussed the resilience-based clinical supervision programme.

Regional Priorities and Partnership Working: Emily and Scarlett discussed the regional priority of partnership working and the collaboration with the Southeast on communication plans. Scarlett provided an update on the clinical competency framework being developed in collaboration with QNI.

Non-Medical Prescribing Working Group: Emily and Scarlett updated the Council on the non-medical prescribing working group, which aims to support social care nurses in accessing and understanding the benefits of non-medical prescribing. They plan to gather sector intelligence through a survey.

CNO Update: Denise provided an update on the impact of winter on the acute sector, the importance of admission avoidance, and the financial challenges facing the healthcare system. She also discussed the focus on mental health and learning disabilities.

Learning Disability and Autism Focus: Denise and Emily discussed the importance of focusing on learning disabilities and autism, including the leader governance group and the need for social care representation in these discussions.

Skills for Care Update: Jill Croskell provided an update on Skills for Care's current priorities, including the development of a strategy around placements, the promotion of social care nursing, and the importance of delegated healthcare activities.

Advanced Social Care Nurse Diploma: Margot shared information about the Advanced Social Care Nurse Diploma, which she developed with Bolton University. The diploma focuses on social care nursing and includes 40 competencies. A new Level 4 programme is also being developed.

NMC Employer Link Service: Michelle Harrison discussed the NMC's Employer Link Service, which helps employers manage potential fitness to practise concerns and encourages local management of concerns. She also provided an update on the NMC's current challenges and improvements.

RCN Independent Health and Social Care Update: Sarah Winfield Davies provided an update on the RCN's work with independent health and social care, including the development of a web page, the RCN Learn platform, and upcoming online learning events.

Care Show and Nursing Live Event: Emily mentioned the upcoming Care Show in London and the Nursing Live event in Birmingham. She encouraged Council members to participate and share their innovative work.

SCNACs Regional Priorities: Emily updated the council on the regional priorities set across all other SCNAC regions and offered the opportunity to council members to be part of working groups attache to these priorities, if they had a special interest in those particular areas.
