Summary

Action Points and Project Updates

Zoe reviewed existing action items, highlighting the revamp of the project spreadsheet and the addition of an "ongoing" tab. She also provided updates on the Easy Read document, which is nearing completion, and noted that the formation of the Data Access Committee is pending due to Professor Laura Shallcross being on leave.

Provider Updates

Lianne Ford from Exemplar Healthcare shared their recent successful go-live, onboarding 56 care homes in just a few hours using the Nourish digital platform. Mike and Kate commended the effectiveness of Exemplar's onboarding process and the support provided.

UKHSA Data Update

Graeme discussed issues with the data extract from NHSE and highlighted the need for continued engagement to resolve them. He also shared progress on the dashboard development, which will integrate four key datasets.

Benchmarking

Victoria spoke about the importance of regional benchmarking and the upcoming formation of an expert advisory group to develop recommendations, which will be presented at the next meeting.

Onboarding Progress

Mike and Lucy reported that 30 new providers have recently joined the project, while also explaining reasons for some providers withdrawing. The upcoming Care Show was identified as a valuable opportunity to expand participation.

Grant Application Presentation

Maria presented her WATCH study proposal, focusing on wastewater surveillance for detecting gut pathogens and antimicrobial resistance in care homes. Attendees provided feedback, particularly on enhancing resident involvement.

Upcoming Engagements

Zoe highlighted upcoming presentations at the Care Show (30 April–1 May) and to CQC inspectors in June. The development of a joint CQC mapping document is underway to support providers in evidencing compliance.

Any Other Business

Francesco announced a learning event in Birmingham on 24 April, and Zoe encouraged sharing the details for wider circulation.

Q&A Section

Q: What is causing delays in the data extract from NHSE?

A: Some data inconsistencies and demographic gaps have been identified. UKHSA is working with NHSE to resolve these issues and assess the impact on timelines.



Q: Will the Easy Read document be available to all providers?

A: Yes, once finalised, it will be uploaded to the website and shared with all participating care homes.

Q: How can providers get involved in the WATCH study?

A: Maria encouraged interested providers to get in touch to co-design elements of the study, particularly around resident engagement.

Q: What support is available during onboarding?

A: The team offers ongoing guidance and technical assistance, with tailored support for Nourish, PCS, and Camascope.

Q: How will benchmarking data be shared?

A: A visual dashboard is in development to allow for regional and provider-level comparisons. The benchmarking expert group will help define the methodology.
