## Note Summary:

**Casey Commission and Delegation:** Deborah Sturdy provided an update on the Casey Commission, which will focus on delegation in nursing. She emphasised the importance of NHS England's involvement and the need for a review of the Code of Conduct to address governance and boundary issues.

**Research and Financial Challenges:** Deborah Sturdy discussed the positive outcomes of the research round table and the financial challenges faced by the sector. She highlighted the importance of resilience-based clinical supervision and the need for collaboration on undergraduate placements.

**Benchmarking and Digital Technology:** Anita updated the group on the progress of the benchmarking project, including meetings with various stakeholders and the potential for funding from NIHR. The project aims to empower staff teams and improve quality through benchmarking.



**Social Care Academies:** Jo-Anne discussed the development of social care academies and the importance of sharing best practices. She mentioned the upcoming RCN Live event in Birmingham and the opportunity to showcase work from the Midlands.

NMC Community of Practice: Tony provided an update on the NMC's efforts to develop a community of practice across the Midlands, including the involvement of social care. The focus will be on sharing best practices and providing support for fitness to practice and revalidation. Social Care Nurse Network: Shirley mentioned the development of a social care nurse network by Skills for Care Midlands, which will provide peer support and link to the community of practice. Training and Development Initiatives: Louise and Katie shared their respective initiatives in Birmingham and the Black Country to provide training and development opportunities for social care nurses. They emphasized the importance of collaboration and funding to support these efforts.

**QR Code for Resources:** Gabriella introduced a QR code initiative that provides care home and domiciliary care nurses with easy access to NICE guidance, training, and other resources. **Essential Care Partners and Regulation 9A:** Diane Mayhew raised concerns about the inconsistent implementation of Regulation 9A, which ensures essential care partners can visit loved ones in care homes and hospitals. The group discussed the need for better training and awareness to address this issue.

**Next Steps and Meeting Schedule:** Anita and Jo-Anne thanked participants for their contributions and mentioned that the next meeting would be scheduled for April. They also highlighted the importance of submitting nominations for the Social Care Chief Nurse Awards.
