### **Summary**

## 1. Opening and Updates



- The meeting was opened by Professor Laura Shallcross, standing in for Zoe (away recording a podcast with The Naked Scientist).
- Emphasis was placed on maintaining momentum and collaboration across partners in the long-term VIVALDI project.
- Louise from EQ Care Group shared that they are re-engaging with the project following internal restructuring and new leadership.

#### 2. VIVALDI Project Progress

- Laura attended the The COVID Inquiry and submitted information regarding VIVALDI Social
  Care. The project has been referenced throughout the inquiry. <u>Care Sector (Module 6) Public Hearings UK Covid-19 Inquiry</u>
- Lucy offered individual meetings to providers needing a refresher on the project background and goals.

#### 3. Media Engagement

- The Naked Scientist podcast is producing a segment focused on the care sector with interviews from staff, residents, and families. <u>Vivaldi: The data revolution coming to care</u> homes | Podcasts
- Participants were encouraged to share ideas for similar public engagement projects.

#### 4. Data Challenges and Pipeline

- Oliver provided a technical update on ongoing data pipeline challenges, particularly with PCS exports and CQC ID codes.
- Graham from UKHSA mentioned a key data feed expected from NHS England on July 10th, with further meetings planned to finalize data-sharing agreements.

#### 5. Onboarding and Engagement

- Lucy reported on recent care home visits and upcoming ones, including:
  - Risedale (Barrow-in-Furness- July)
  - Exemplar ( October)
  - HC-One (November)
  - Nightingale Hammerson (December)
  - Care Show (Birmingham- October)
  - Parliamentary Reception (January 2026)
- Efforts to re-engage homes that have left the project are ongoing. These are minimal.



#### 6. Research Training and Capacity Building

- Plans are underway to develop training and capacity-building programs for care home staff to improve understanding of research processes.
- Kate Meacock and others noted encouraging interest and feedback from care home staff during visits.

#### 7. Future Funding Opportunities

- A grant application (~£6 Million) is in development.
- Norovirus vaccine trial in care homes.
- A project manager and support through a Clinical Trials Unit will be included in the proposal.

#### Q&A

Q: What's causing delays with the VIVALDI data pipeline?

A: There are issues with data exports (especially from PCS) and technical mismatches with CQC ID codes and NHS numbers.

Q: Will the upcoming NHS data feed help?

A: Yes. NHS England is expected to provide a new feed on July 10th, which should significantly improve the situation.

Q: How will care home staff be trained in research?

A: Plans are underway to develop accessible materials and conduct interviews to shape the training, aiming to build confidence and engagement with research.

Q: Will the norovirus vaccine grant include funding for project management?

A: Yes. A dedicated project manager and operational support through a Clinical Trials Unit will be part of the proposal.

Q: Is there potential input into NHS strategy documents?

A: Yes, participants are encouraged to review the NHS 10-Year Plan and NIHR prevention programs to identify points where adult social care research can contribute.
